# UTILITY USER TAX MONTHLY TAX RETURN

The Utility User Tax is imposed on every person in the City of Vallejo using electricity and gas at the rate of 7.5% of utility charges, communication services at the rate of 7.3% of communication charges, and prepaid wireless at the rate of 6.5% of prepaid wireless charges. Utility User Tax filings are due on or before the twentieth (20th) day of each calendar month for the total gross receipts and the amount of the tax owed for the preceding calendar month, and become delinquent thereafter. **A separate tax form must be submitted for each service type.**

Note: TAX DELINQUENT IF NOT RECEIVED WITHIN 20 DAYS FROM END OF TAX MONTH

Line 7. Total Utility User Tax Due (add lines 4(a) thru 6)
