

RESOLUTION NO. 13-138 N.C.

A RESOLUTION OF THE CITY COUNCIL AMENDING THE FISCAL YEAR 2013-2014 CIP BUDGET AND AUTHORIZING THE PARTIAL IMPLEMENTATION OF (PB C2 PROJECT), THE FLORENCE DOUGLAS & CONVERSATION SENIOR CENTERS PROJECT

BE IT RESOLVED by the Council of the City of Vallejo as follows:

WHEREAS, Pursuant to Resolution No. 12-064 N.C. the City Council of the City of Vallejo declared its intent to establish a Participatory Budgeting process with the allocation of 30% of the 1% sales tax monies, Measure B funds, collected over a 15 month period from April 1, 2012 through June 30, 2013; and

WHEREAS, upon the completion of the Participatory Budgeting election process, the results were presented to this Council on May 28, 2013, and twelve projects were selected by the public, including 'PB C2 the Florence Douglas & Conversation Senior Centers Project' as described in the 'Description of voter Approved Project Proposal' attached to the staff report on that date, hereinafter, the "Project"; and

WHEREAS, this City Council directed staff on July 9, 2013 to bring a Resolution forward to implement the Florence Douglas Senior Center portion of this Project; and

WHEREAS, Pursuant to Resolution No. 12-138 N.C. the Council adopted the Participatory Budgeting Rulebook determining that Participatory Budgeting Projects are eligible for funding if they meet the following criteria:

1. They benefit the public.
2. Are a one-time expenditure that can be completed with funds from the FY 2012-2013 budget.
3. Are implemented by the City of Vallejo, or in collaboration with the Vallejo City Unified School District, the Greater Vallejo Recreation District, or any other Public Agency, non-profit organization, or religious institution that operates in Vallejo. Projects implemented by non-city public agency must also include financial or value in kind contributions. Projects implemented by non-profit organizations or religious institutions must also meet the eligibility guidelines used by the Housing and Urban Development (HUD) Community Development Block Grant (CDBG) Program; and

WHEREAS, the Council has received evidence and testimony on the Project.

NOW, THEREFORE, BE IT RESOLVED that the City of Vallejo makes the following findings:

The City Council of the City of Vallejo finds that adding the \$34,180 originally destined to fund the 'conversations lounge' portion of the (PB C2 Project) the Florence Douglas & Conversation Senior Centers Project would be best allocated towards cost overruns for the Florence Douglas Senior Center portion of this Project, so that these funds may be used to fund the capital improvements pursuant to Resolution No. 13-121 N.C., and such will improve the quality of life for Vallejo residents, will improve the City-owned facility, making it safer for senior residents and provide energy efficiency thus reducing ongoing operating costs of the Florence Douglas Senior Center.


FURTHER, BE IT RESOLVED that should there be remaining funds after the completion of the scope of work pursuant to Resolution No. 13-121 N.C. these funds shall be re-allocated towards the Participatory Budgeting Project allocation adopted in the FY 2013-14 budget.

FURTHER, BE IT RESOLVED that subject to the findings and the conditions set forth in this resolution, the City Council hereby:

1. Amends the Fiscal Year 2013-14 CIP Budget, and Authorizes the City Manager to establish the Florence Douglas Senior Center project and redistribute budgeted appropriations of \$34,180 from Project Number PB-000 to CIP Project PW9813 to implement cost overruns of the Florence Douglas Project, and further grants the City Manager the administrative authority to execute any and all agreements, subject to review by the City Attorney, and to take any and all required actions to implement the Project as set forth in this resolution, consistent with the Vallejo Municipal Code, the Participatory Budgeting Rule book and any other applicable authority and additionally authorizes the City Manager to amend the Project, so as to ultimately promote the goals of the Project as set forth in the 'Description of voter-approved Project Proposal'.
2. Directs the City Manager to report to the City Council once the project is complete.
